REVOLVING LOAN FUND

The State of Wyoming received an \$800,000 RLF grant in 2018 making funding available for distribution to eligible entities within the state of Wyoming for cleanup.

- The RLF provides low-interest loans and/or grants to eligible public and private sector entities to clean up Brownfields sites in Wyoming.
- A portion of the RLF can be used as a cleanup grant for eligible municipalities in the state.
- The RLF can help to bridge the gap in financing of a cleanup and redevelopment project in Wyoming.
- Projects will be evaluated based on environmental impact, public health and safety, economic development, community benefit, and community revitalization potential.

A Brownfields site is defined as 'real property, the expansion, redevelopment, or reuse of which may be complicated by the presence of a hazardous substance, pollutant, or contaminant'.

- Located in Wvoming
- Enrolled in our Voluntary Remediation Program (VRP)
- Qualify as a 'Brownfields Site': real property, the expansion, redevelopment, or reuse of which may be complicated by the presence of a hazardous substance, pollutant, or contaminant.
