The State of Wyoming is considering an investment in BWX Technologies (BWXT), to build an advanced nuclear fuel (TRISO) manufacturing facility near Gillette. The Large Project Energy Matching Fund has recommended a \$100 million dollar investment, which is matched by BWXT's private commitment of over \$400 million. This project is projected to create more than 200 jobs and additional long-term economic benefits, including an increased tax base and a valuable new energy export. The facility is not a reactor or a spent nuclear fuel storage site.

ALL voices must be heard! It is vital that Governor Gordon and the Wyoming Energy Authority hear what citizens think about this opportunity. Your comment helps our leaders make decisions that reflect your opinions for Wyoming's future.

HELPFUL INFORMATION ABOUT THE PROJECT

1. Projected Benefits of the Project

- **200+ High-Quality Jobs:** The facility is projected to create over 200 high-quality, high-wage jobs in the northeast region of Wyoming.
- **Invest in Wyoming's Future:** This project aims to establish additional high-tech career paths needed to retain and return more young people to Wyoming.
- **Vertical Integration:** This project leverages Wyoming's existing uranium resources, turning them into a high-value advanced energy export and on-shoring more of a critical energy supply chain.

2. About the Company

- a. **Track Record:** [BWXT](#) is a 100-year-old company and the sole provider of nuclear reactors for the U.S. Navy.
- b. **Community Engagement:** BWXT conducted a statewide supply chain roadshow and listening sessions to engage with Wyoming communities and potential local manufacturers and service providers.

3. About the Proposed State Investment

- **\$400M+ Private Investment:** BWXT is committed to Wyoming, investing over \$400 million in private funds (four times the state's \$100 million match) from the already-appropriated [Large Projects Energy Matching Fund](#).

4. Safety & Security

- **Facility Focus:** This is a fuel manufacturing site; it is explicitly not licensed to produce or store any high-level radioactive waste or spent nuclear fuel.
- **Secure Fuel Supply:** This facility is crucial for national security by ensuring a secure, reliable, domestic supply of fuel for the next generation of advanced nuclear reactors.
